The City of Springfield funded the operation of a low barrier overflow emergency shelter throughout 2022 and the winter of 2023 that accommodated both men and women. The consistency of this operation throughout the year and the reduction of barriers resulted from both changes in capacity and policy that created opportunities for people who might otherwise be unsheltered to utilize the program which led to an increase in the number of people in Emergency Shelter and a reduction in the number of people experiencing unsheltered homelessness. Most transitional housing programs in our community have returned to operating at capacity levels similar to pre-pandemic levels. Due to inadequate levels of resources for both Rapid Rehousing and Permanent Supportive Housing, the Heartland Continuum of Care\'s system to address homeless continues to experience long wait times on Coordinated Entry which results in more individuals and families utilizing Emergency Shelter and Transitional Housing programs while working toward permanent housing.

The City of Springfield funded the operation of a low barrier overflow emergency shelter throughout 2022 and the winter of 2023 that accommodated both men and women. Historically in Springfield/Sangamon County, an overflow shelter has been operated November through March to provide safe beds during cold weather. The funding that allowed the shelter to be open throughout 2022 broke the cycle of displacing people each spring as temperatures begin to rise. The consistency of this operation throughout the year contributed to additional capacity to provide services to people who have historically experienced unsheltered homelessness. A case manager was hired to provide services and connectivity to other programs and services during day time hours. Additionally, outreach through the Springfield Police Department\'s Homeless Outreach Team and Community Care Coordinator in partnership with the Heartland Continuum of Care\'s Housing Navigator created new pathways to permanent housing for people who are unsheltered through improved access to housing programs and housing problem solving approaches. The Community Care Coordinator was a new position created in 2022 to work with the Springfield Police Department to co-respond with officers and provide support for people experiencing homelessness with a focus on connectivity to services instead of criminalization. The Community Care Coordinator developed relationships through outreach and provided referrals to individuals to shelters and other services. The Community Care Coordinator in cooperation with the Housing Navigator employed a Housing Problem Solving approach to help people with income quickly end their homelessness while also providing pathways to housing for people waiting for scarce supportive housing resources.

In addition to the changes to the availability of shelter beds, operational practices shifted to become increasingly low barrier in the overflow shelter and in other emergency shelters as well. Low barrier policies helped to ensure people could access beds and worked to minimize people being excluded from service for various reasons. Through efforts of the Heartland Continuum of Care\'s Emergency Shelter task group, Emergency Shelters, community members, and other service providers work together to communicate and seek solutions for complex challenges as they arise. The Heartland Continuum of Care worked to strengthen Coordinated Entry efforts by providing ongoing trainings for staff of multiple organizations in efforts to reduce barriers to getting on the Coordinated Entry list. The development of Springfield & Sangamon County\'s 2022-2028 Strategic Plan to Address Homelessness provides a local framework for addressing homelessness more effectively and providing increase housing opportunities for people experiencing homelessness. While efforts to expand resources are still underway, service providers and community partners have already begun new efforts to provide more intentional outreach and collaboration to people who are unsheltered. The strengthened practices and policies have helped to reduce unsheltered homelessness and prevent additional community members from experiencing unsheltered homelessness.

Please provide a brief description of these specific factors (500 word limit):

The City of Springfield funded the operation of a low barrier overflow emergency shelter throughout 2022 and the winter of 2023 that accommodated both men and women. The consistency of this operation throughout the year and the reduction of barriers resulted from both changes in capacity and policy that created opportunities for people who might otherwise be unsheltered to utilize the program. Additionally, outreach through the Springfield Police Department\'s Homeless Outreach Team and Community Care Coordinator in partnership with the Heartland Continuum of Care\'s Housing Navigator created new pathways to permanent housing for people who are unsheltered through improved access to housing programs and housing problem solving approaches.
